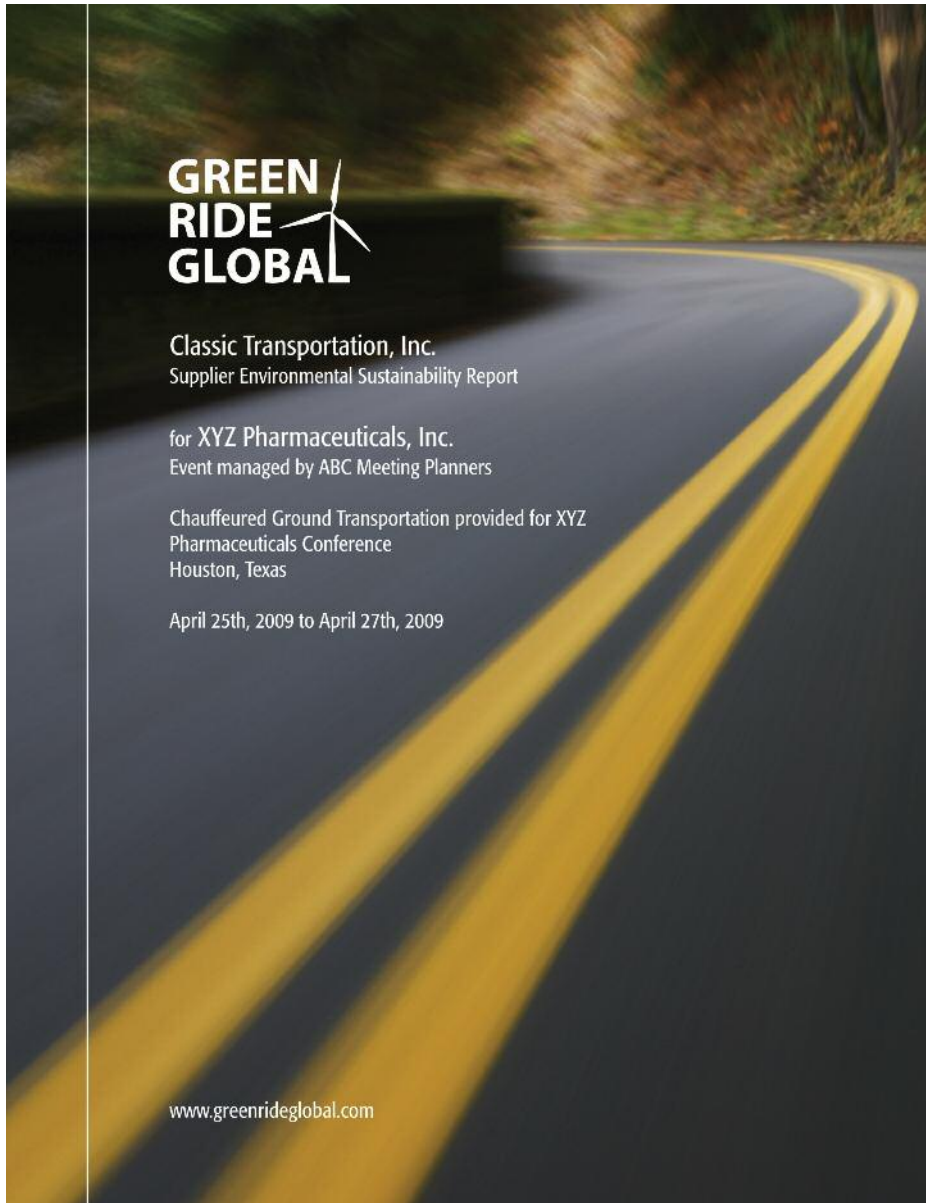

The Carbon Accounting™ System
To allow for the accurate monitoring of greenhouse gas inventories between countries, international organizations accountable for the tracking and reporting of greenhouse gases have aligned on a system that categorizes GHG-emitting activities into three main areas: Scope 1, Scope 2 and Scope 3.

SCOPE 1 EMISSIONS
Scope 1 emissions are those that are directly caused by an organization's business activities through stationary combustion (e.g. burning fuel in a boiler), mobile combustion (e.g. burning fuel in an aircraft), and refrigerants not containing the greenhouse (e.g. fugitive refrigerant gases).

SCOPE 2 EMISSIONS
Scope 2 emissions are caused indirectly by an organization's business activities through the purchase and consumption of electricity and steam from a utility.

SCOPE 3 EMISSIONS
Scope 3 emissions are indirect emissions from all other activities caused by the organization. They include GHG emissions from employee travel, employee commute, waste disposal, supply chain practices, and product transport.

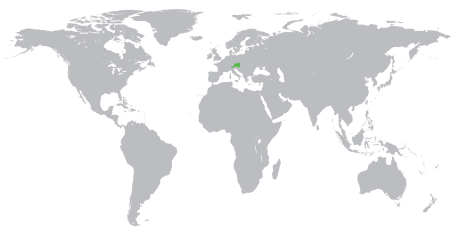

GHG Emissions Intensity from Ground Transportation

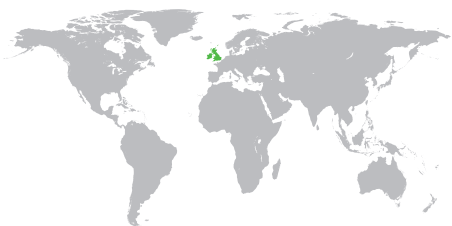
