

Coronavirus Poll Results

February 2020



Q1) How concerned are you personally about the coronavirus spreading around the world, including the United States?

- Very concerned: 40%
- Somewhat concerned: 49%
- Neither concerned nor unconcerned:5%
- Not very concerned: 5%
- Not at all concerned: 1%

Q2) Do employees at your company travel to China and other international destinations for business travel?

- Yes: 89%
- No: 11%

Q3) How much concern have your employees expressed about the coronavirus spreading around the globe?

- A lot: 27%
- Some: 42%
- Not too much: 26%
- None: 6%



Q4) What concerns you the most about your travelers traveling internationally in terms of the coronavirus? Select up to three:

- Traveler health and safety: 90%
- Traveler concerns about their personal safety: 48%
- Disruption of travel due to airport closures, airline cancelations and/or delays: 40%
- The disease could spread to the United States, impacting domestic travel: 29%
- Liability concerns if something happens to one of our travelers should they contract the disease: 25%
- Canceling or delaying international business travel: 18%
- Other: 7%

Q5) How concerned are your company's executive/senior leadership about the coronavirus and its potential impact on business travel and employee safety?

- Very concerned: 40%
- Somewhat concerned:40%
- Neither concerned nor unconcerned: 7%
- Not very concerned: 5%
- Not at all concerned: 1%
- Unsure: 8%



Q6) How concerned are your employees about health screenings at airports to try and detect potentially affected travelers?

- Very concerned: 13%
- Somewhat concerned: 37%
- Neither concerned nor unconcerned: 22%
- Not very concerned: 8%
- Not at all concerned: 3%
- Unsure: 18%

Q7) How likely do you think your employees will change their travel plans to avoid flying and business travel due to the coronavirus?

- Very likely: 46%
- Somewhat likely: 34%
- Neither likely nor unlikely: 9%
- Not very likely: 11%
- Not at all likely: 1%

Q8) In general, which statement best describes your organization's travel policy?

- Mandated, meaning it states the policies and rules that employees are required to follow as a condition of employment or they are not reimbursed: 38%
- Guidelines, meaning it states guidelines that employees should observe when they travel but makes exceptions for travelers: 47%
- Hybrid: 16%





Methodology

The poll was fielded from January 27-31, 2020 and received responses from 247 GBTA global buyer members yielding an eight percent response rate.
